SEALED Tender are invited by Shree Narayana Cultural Mission (“SNCM” or short), Ahmedabad as per terms and conditions stipulated in the tender document for “TENDER FOR PAINTING WORK” SHREE NARAYANA CULTURAL MISSION, AHMEDABD from firms/company having experience at least of 5 years of PaintWork.

- (A) The Final Tender Cover containing both (1) Technical & Commercial Bid Cover and (2) Price Bid Cover (in separately sealed covers) mentioning as “Tender No SNCM/Outward/WO-PAINT/ 2019 dated 7<sup>th</sup> May, 2019 for the Painting Work at SNCM along with last date of submission of the Tender addressed to the General Secretary, Shree Narayana Cultural Mission, Ahmedabad should be submitted on or before 15<sup>th</sup> May 2019 (before 4 pm).
- (B) On the top of envelope, it should be clearly mentioned “TENDER FOR PAINTING WORK” in Shree Narayana Cultural Mission.
- (C) SNCM shall not be responsible for any delay and shall not accept any tender after 4PM on 15<sup>th</sup> May 2019 and the same will not be considered.
- (D) SNCM Management reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
- (E) The Bidder has to submit a work completion certificate issued by the construction committee while claiming the balance 50% payment (Final Payment)
- (F) The Payment will be made by a/c payee cheques only in favour of the bidder.

(G) The Bidder should have a minimum Turnover of Rs. 25 Lakhs for the last two financial years. The bidder should submit the certified balance sheet and income tax return for the last two consecutive years to substantiate its financial capability.

(H) Earnest Money Deposit (E.M.D.)

i) The Tenderer shall be required to furnish 5% of the total work order value as EMD by way of Demand Draft drawn in favor of “Shree Narayana Cultural Mission”.

**ii) The EMD of successful Tenderer shall be converted in to security deposit and the same will be returned after satisfactory completion and after 15 months from the date of completion of the total work.**

iii) The Security deposit shall not bear any interest.

iv) The EMD draft should be put in the Technical Bid cover only.

v) Offers received without EMD are liable for rejection.

I) Taxes: GST is applicable should be mentioned clearly and separately with the percentage of taxes applicable.

J) Penalty Clause:

i) In case of non-completion of the work within the mutually agreed period, a penalty of 1% of the total Tender value will be levied on the Bidder,

ii) However, if the work is delayed for more than 20 days, another 3% will be levied.

iii) SNCM Management reserves the right of exceeding the penalty Terms on the basis of delay incurred in the work.

K) Dispute and Arbitration: In the event of any disputes or differences of whatsoever nature arising out between the parties to the agreement out of or

relating to the agreement or breach thereof, shall be settled by arbitration proceedings in accordance with the provisions of Arbitration and Conciliation Act, 1996 as amended from time to time and the award made in pursuance thereof shall be binding to both the parties.

L) Indemnity Clause: Each Party (the “Indemnifying Party”) agrees to defend the other Party, its affiliates and each of their respective officers, directors, employees, contractors and agents (each an “Indemnified Party”) from and against any action, claim, suit, investigation or other proceeding brought by a third party (a “Claim”) to the extent such Claim results from the Indemnifying Party’s breach of this Agreement or an IPA or the negligence, willful misconduct or fraud or violation of law on the part of the Indemnifying Party, its officers, directors, employees, agents or other representatives in connection with this Agreement/Contract. The Indemnifying Party will indemnify and hold harmless the Indemnified Party from any liabilities, losses, damages, judgments, awards, fines, penalties, costs and expenses (including reasonable attorneys’ fees and costs of defense) incurred by or levied against such Indemnified Party as a result of such Claim.

**M) Any overwriting on any original documents including Price bid will make the entire bid disqualified.**

N) The Tenderer has to obtain Personal Accident Insurance policy for all its work force who are working in our premises. Before starting the work you are required to submit the copy of the insurance policy.

O) As per the norms, the contractor will ensure to provide all types safety equipment and tools to its work force.

**P) DOCUMENTS TO BE ATTACHED IN THE TECHNICAL BID COVER:**

- i) GST certificate/ PF/ESIC registration certificate
- ii) Copy of Work Order proving their capability and experience of painting work.
- iii) Earnest Money Deposit by way of a/c payee cheque in favour of “Shree Narayana Cultural Mission”.

- iv) Copy of PAN Card (Self Attested)
- v) Copy of Balance Sheet and Income Tax Returns for the last two consecutive years.
- vi) Copies of PF and ESIC registrations.

**Q) The Tenderer are required to put rubber stamp and sign all the documents and Annexures.**
