

1. Introduction:

Shree Narayana Cultural Mission (SNCM), Satellite Campus, invites sealed proposals from reputed and eligible contractors/agencies for carrying out single-phase electrical wiring work for Air Conditioners (ACs) in the CBSE Building and A-Building.

2. Scope of Work

The selected contractor shall be required to execute the following work:

- 1. New single-phase wiring from the main electrical panel to the respective buildings.
- 2. Distribution of wiring from the building entry point to all floors.
- 3. Further wiring from each floor to the respective classrooms designated for AC installation.
- 4. The work must include all materials, labour, fittings, fixtures, conduits, accessories, testing and commissioning.
- 5. Detailed specifications including wire size, brand, quantity, circuit planning, and other technical requirements are provided in Annexure—A (attached).

3. Eligibility Criteria

Bidders must meet the following minimum requirements:

- Must be a registered electrical contractor.
- Minimum 3 years of experience in similar electrical wiring work.
- Should have executed at least two similar projects in educational institutions or large buildings.
- Must possess valid PAN, GST registration, and other statutory compliance documents.

5. Submission of Proposal

Tender Fee: The Bidder must be submit A tender fee of **Rs. 1,000/- in cash** at the account department of Shree Narayana Cultural Mission. Please note that this Tender fee is non-refundable, and payments via electronic mode or cheques will not be accepted.

Earnest Money Deposit: The bidders must submit along with their bids of Rs. 50,000/-in the form of A/c Payee's Cheque in favor of "**Shree Narayana Cultural Mission**" payable at Ahmedabad and can be held till the Performance Bank Guarantee comes into effect.

Performance Bank Guarantee: This shall be Rs. 50,000, and it shall be returned only after 1 year of satisfactory working of the entire products. Performance security deposit will be paid in the form of Bank Guarantee.

Terms & Conditions

- The contractor must follow all relevant safety standards and electrical codes.
- All materials used should strictly adhere to the specifications given in Annexure–A.
- Work must be completed within **20 days** from the date of work order.
- SNCM reserves the right to accept or reject any proposal without assigning any reason.
- Each Bidder shall submit ONLY one bid. A Bidder who submits more than one bid will be disqualified.
- Transportation No way bills for transporting the materials shall be issued to the successful bidder by SNCM. Rate should be inclusive of all. No separate charges whatsoever will be paid to the vendor.
- Any other items apart from the BOQ mentioned above required for successful commissioning of the project will be in the scope of the bidder.
- Any damage to existing infrastructure during work shall be rectified by the contractor at their own cost.
- All materials supplied to the SNCM shall be new and should have been manufactured within six months of delivery.
- SNCM reserves the right to negotiate the quoted price with the successful bidder.
- Warranty on wiring and materials should be clearly mentioned in the bid.
- The work should be completed within the stipulated time decided during the negotiation meeting from the date of purchase order. In case of failure of the contractor to complete the work in scheduled time period from the date of allotted work, a penalty @ 0.5% of work order amount per week delay, maximum up to 5% of work amount. The amount shall be either deducted from the bills of the contractor or from Earnest Money Deposit. SNCM shall have the right to deduct the penalty from the bills or any other amount payable to the contractor in such manner as the owner deems fit. After 5 weeks of delay, SNCM shall have absolute right to terminate the contract with the Contractor and get the work completed through some other contractor, at the cost of such first mentioned Contractor. In case Owner terminates the contract for delay, EMD amount shall not be paid to the Contractor and shall be adjusted against the cost of getting the work completed through some other contractor.
- In case of unanticipated/unforeseen delay because of the SNCM's action, the SNCM and the bidder may mutually agree to the period of delay and for the said period, liquidity damage clause will not be applicable.

Evaluation Process

- **Technical Bid** will be evaluated first based on eligibility, past experience, and methodology.
- Financial Bid of only technically qualified bidders will be opened.
- Lowest eligible bidder (L1) will normally be awarded the contract, subject to SNCM approval.
